FREQUENTLY ASKED QUESTIONS

01. What is included in my annual membership commitment (dues)?

- Worship and meaningful holiday and Shabbat experiences for all ages.
- Clergy who are by your side at times of joy and crisis.
- Access to educational experiences such as Noar Sunday, teen learning, adult education programs for young families and more (including discounted preschool tuition)
- Operations and the day-to-day work that sustains our beautiful campus and vibrant community.
- Opportunities to build community through age and stage events, trips with clergy and more!

Membership dues are set at a level that allows us to perform these essential services. When membership dues are below the annual amount, we face ongoing operating deficits, strain on staff and programs, and less flexibility to respond to the needs of our members and wider community.

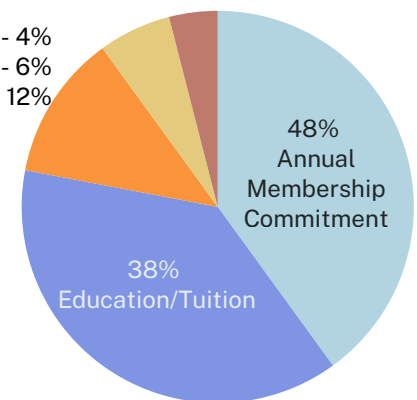
02. What is the Annual Security Fee?

All members are asked to pay an annual security fee that directly offsets the cost of the security endeavors at Temple Sinai. We employ guards whenever the building is open to ensure the utmost safety and security of all members and guests. In addition, these funds support critical physical security infrastructure such as enhanced alarm and surveillance systems, license plate readers, secure perimeter fencing, and modern communication tools like radios and walkie-talkies that allow for rapid, coordinated response. These investments reflect the reality of a significantly heightened threat environment, as antisemitic incidents and attacks targeting Jewish institutions have risen sharply over the past several years, requiring us to take proactive and visible steps to ensure safety.



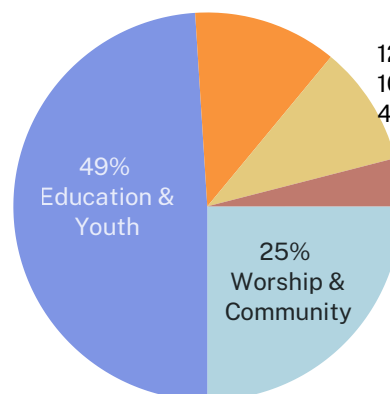
03. How is Temple Sinai Funded?

Security Fee - 4%
Restricted Funds - 6%
Miscellaneous - 12%

What is the Building Maintenance Fund?



All members are required to support the Building Maintenance Fund via a pledge that can be paid over eight years. This Fund ensures the necessary reserves to maintain our building and overall campus.

For members 64 and under, the amount is \$6,000 payable over 8 years beginning after your first year of membership or upon turning 36. Should you pay it in your first year of membership there is a discounted rate of \$4,000.

For members 65+, the pledge is \$3,000 payable over 8 years beginning after your first year of membership. Should you pay it in your first year of membership there is a discounted rate of \$2,000.
